### BATTLE CONTINUES FOR A FAIR STATE BUDGET

Democratic leadership in the Connecticut State House of Representatives and the State Senate continue to battle with the Rell administration over a fair budget. ## RIP RETIREES MAY NOT GET A CHECK IN JULY

The State Retirement Division has informed 1,700 recent retirees who took the retirement incentive that they will not see a check in July. They will receive a two month check in August. This is due to the Governors unrealistic expectation to complete the incentive program in two months and the Retirement Division of the State Comptroller not having adequate staffing to complete the work. This office of hard working state workers has been understaffed since the 2003 ERIP.

## SHOE MONEY PAYMENTS IN JULY

For members whose agencies require them to wear safety shoes:

Effective July 1, 2009 the Safety Shoe allowance provided under Article 19 (Safety) shall be \$135.

## UNION STEWARD ELECTIONS

Per the CEUI by-laws, Union stewards are elected every 4 years. This year, in late October and early November, elections will be held for CEUI stewards at worksites state wide. Nomination forms will be posted at the worksite at least 10 days prior to the election.

## HEALTHCARE CHANGES Effective July 1, 2009

These changes are only for active employees and those who retire after 7-1-2009.

### Prescription co-pays

- Tier 1 : \$ 5.00 co-pay for generic
- Tier 2 : \$10.00 co-pay for preferred name brand
- Tier 3 : \$ 25.00 co-pay for non-preferred name brand drugs (only 15% of all drugs)

There is a 90 day phase-in period from 7-1-09 to allow a user of a non-preferred name brand drug to change or have the doctor submit a medical report to continue using the non-preferred drug at the \$10.00 co-pay. If the doctor states that there is a medical reason to take a preferred name brand drug you will pay the lower tier co-pay.

For maintenance drugs (taken every day over a long period) have your doctor write the prescription for a 90 day supply, and you will save with one co-pay.

### Doctors office co-pays decrease

- Continued free well child care
- Adult routine physical exams per carrier/plan decrease to \$ 5.00
- Routine gynecological exams, including pap smear test per carrier/plan decrease to \$5.00
