Retirement Information for Members who Plan to Retire AFTER 2022: Per the SEBAC 2011 Agreement, members who were hired before July 1, 2011 and who plan to retire AFTER July 1, 2022 will have the option to elect to make a small payroll contribution in order to retain the current retirement ages beyond July 1, 2022. In early 2013, you will be receiving information from the Office of the State Comptroller indicating 1) how to sign up if you wish to make these contributions and 2) what your calculations for that contribution will be.

In the meantime, we have prepared a Frequently Asked Question and Answer document related to this topic that is available at www.ceui.org and will also be distributed to stewards. Health Enhancement Plan: As a reminder, you can obtain a list of the requirements for the Health Enhancement Plan (HEP) at the Office of the State Comptroller's website: http://www.osc.ct.gov/empret/ indxhlth.htm

Vision Exams: Per the SEBAC 2011 Agreement, members are required to obtain a vision examination every 2 years and the co-pay associated with that exam is to be waived. We have had a number of members who have been wrongly charged for their co-pay and the Health Care Cost Containment Committee is currently working on a resolution of the issue. If you are charged a co-pay for your vision examination, please contact George Spurlock at (860) 343-8722. Dental Exams: Per the SEBAC 2011 Agreement, members are required to have a routine cleaning twice per year at no cost to the member (United Healthcare Enhanced Plan members must see an in-network dentist). HCCCC is working on a resolution to this issue. If you have been charged a co-pay for a routine dental cleaning or exam, please contact George Spurlock at (860) 343-8722.

DOT CDL Drivers: We continue to have a number of members who have let their medical card lapse and face discipline as a result. You are required to carry a valid medical card as a condition of employment and we strongly suggest making your physical appoint-

ments well in advance of your expiration date. If you have any questions about your CDL medical card, contact Cara Wachsman at (860) 343-8719.

<u>Cell Phones:</u> As a reminder, Connecticut prohibits citizens from using cell phones while driving unless they are equipped with a "hands-free" device. Members are reminded to be particularly mindful of this law when driving State vehicles as they could be subject to discipline if found to be in violation of the state law while driving a state vehicle.

Year 2012:

Year 2013:

April 2013 — Longevity paid

July 2013 — 3% General Wage Increase [Reminder: the July 1, 2013 GWI will be delayed to recover the exact amount of the 2 ½ % raise paid in July and August 2011. (Estimated 2-3 pay periods)]

July 2013 — Members who are not already contributing to retiree health insurance will begin contributing ½% July 2013 — Safety Shoe money paid [\$135.00] October 2013 — Longevity paid

Year 2014:

January 2014 — Annual Increments & Top Step Bonus April 2014 — Longevity paid

July 2014 — 3% General Wage Increase [Members who began retiree healthcare contributions in 2013 will increase their contribution by 1 1/2%]

July 2014 — Safety Shoe money paid [\$135.00]

April 2014 — Longevity paid

Year 2015:

January 2015 — Annual Increments & Top Step Bonus April 2015 — Longevity paid

July 2015 — 3% General Wage Increase [Members who began retiree healthcare contributions in 2013 will increase their contribution by 1%]

July 2015 — Safety Shoe Money paid [\$135.00]

October 2015 — Longevity paid

Year 2016:

January 2016 — Annual Increments & Top Step Bonus April 2016 — Longevity paid

July 2016 — Safety Shoe Money paid [\$135.00]
